## **SUMMARY**

As a Head lifeguard it is your responsibility to ensure the safety of all patrons in the pool area. Enforcing pool rules, promoting consistency, and remaining alert are the most important aspects of your position. Head Lifeguards guide patrons and staff to safe behavior, intervene when necessary to maintain safety, and perform any required rescues. You will be a supervisor to the Lifeguard staff. You work under the direct supervision of the Aquatic Facility Manager

## **MINIMUM QUALIFICATIONS**

During employment as a Head lifeguard for Chippewa Falls Parks and Recreation, it will be the responsibility of all staff to maintain current certification and proficiency in:

- American Red Cross Lifeguarding
- American Red Cross First Aid
- CPR/ AED for the Professional Rescuer

Re-certification classes are offered on an as-needed basis, and are paid hours-

## **KNOWLEDGE AND SKILLS:** include the following. Other duties may be assigned.

- Thorough knowledge and application of lifeguarding surveillance and rescue techniques
- An understanding of facility characteristics, rules, policies and procedures
- Leadership and public relations skills
- Decision-making skills
- All Lifeguards must be able to swim a minimum of 300 yards continuously with good form.

## **RESPONSIBILITIES**

- Recognize and respond quickly and effectively in emergencies
- Enforce all aquatic facility policies, rules and regulations
- Inspect the facility on a daily schedule and report any unsafe conditions or equipment to the supervisor
- Complete daily records and reports
- Participate in leading regular in-service training sessions
- Maintain fitness level (swimming skills, strength and endurance)

- Create daily rotation schedule
- Complete lifeguard checks
- Oversee daily facility maintenance, including but not limited to: Cleaning bathrooms, pool deck, water testing, water filter system, lifeguard office and water pumps.
- Complete additional duties as assigned by the Aquatic Facility manager

#### **EDUCATION AND/OR EXPERIENCE**

• Current High school or college student. No degree required.

## **CERTIFICATES, LICENSES, REGISTRATIONS**

- Must have a reliable means of transportation.
- Willing to adhere to preferred certification in-season if all are not complete

## PHYSICAL DEMANDS
